ORDER:

In the G.O. first read above, orders were issued according permission to the Bapuji Social Welfare Society, Narasaraopet, Guntur District for starting DMLT (LT) Training in the name of Navodaya Lab Technician Course, Shalem Nagar, Narasaraopet with intake capacity of ten (10) studcents. Subsequently orders were issued in the G.O. 2nd read above enhancing the seats from 10 to 20 in DMLT course in the said Institute.

2. In the letter 3rd read above, the Secretary, A.P. Para Medical Board, Hyderabad has brought to the notice of the Government that without obtianing permission from Government, the said Institute has been shifted from Narasaraopet, Guntur District to Tadipatri Road, Ananthapur District; enhanced seats and running additional courses i.e., DOA, D Dairy DMST and DANS.

3. The Government after careful examination of the matter have decided to initiate necessary action against M/s.Bapuji Social Welfare Society, Narasaraopet, Guntur for committing the irregularities as detailed above and accordingly issued a Show Cause Notice in the Memo. 4th read above to the President, M/s.Bapuji Social Welfare Society, D.No.12-1-106, Shalem Nagar, Narasaraopet, Guntur District and the Correspondent, Navodaya DMLT (LT) Training Institute, 19/3/564, Gaffoor Colony, Old Town, Tadipatri Road, Ananthapur directing them to show cause within fifteen days from the date of receipt of the Notice as to why the permission accorded to them vide reference 1st read above to start Diploma Course in Medical Lab Technology Training should not be cancelled. Inspite of receipt of the Show Cause Notice, no explanation has been received from them.

4. The Government have therefore, come to a conclusion that the Bapuji Social Welfare Society have committed the irregularities mentioned at para 2 above and therefore, decided to cancel the permission given to the Bapuji Social Welfare Society, Shalem Nagar, Narasaraopet, Guntur District and accordingly the permission accorded to the Bapuji Social Welfare Society, Shalem Nagar, Narasaraopet, Guntur in the G.O. first read above to run Diploma Course in Medical Lab Technology Training in the name of Navodayas Lab Technicians Course (DMLT), Shalem nagar, Narasaraopet, Guntur District is hereby cancelled.

5. The Secretary, A.P. Para Medical Board, Vijayawada shall take necessary action accordingly.
