PRELIMINARY SCREENING RESULTS

1. Notification issued vide RC No 2980/E11B/2016 DT 28.01.2016 for recruitment to the post of HOSPITAL ADMINISTRATORS (MANAGERS) and 259 application were received. All the application have been screened for the eligibility as per the stipulations mentioned in the notification
2. Candidates with the following mandatory qualifications alone are found fully qualified for the further round of screening and candidates who did not possess any requisite qualifications are found ineligible for further screening.
 - a. Non Medical Graduate with MBA Hospital Administration/`Post Graduate degree in Hospital Administration in regular course
 - b. 5 years of post qualification experience working in Government or Private Hospitals
 - c. 3 Years of work experience in managerial roles in hospitals.
3. The list of candidates with the preliminary screening result is attached.
4. Candidates who are qualified in preliminary screening have to attend the second level screening (for Computer proficiency) and candidates who are in turn qualified in computer proficiency test will be called for interview. Other requirements mentioned in the notification would be assessed in the personal interview. Date and Venue for Computer proficiency test will be intimated to the qualified candidates later.
5. Candidates who are not qualified can submit their objection on or before 24.02.2016 3.00pm in person to the O/o Director of Medical Education, Government of AP Sultan Bazar Koti Hyderabad.
