Applications are invited from the eligible candidates by the Director of Medical Education, A.P, Hyderabad, to fill up the one (1) vacant post of Child Psychologist in Niloufer Hospital, Red Hills, Hyderabad in the format given below:

1) Child Psychologist.

No. of Vacancies -01 (at Niloufer Hospital, Hyderabad)
Scale of Pay - Rs.9285 – 21550/- in the R.P.S. of 2005.

Qualification : 1) Must passed M.A. (Psychology) of a University in India established or incorporated by or under a Central Act, Provincial Act or a State Act or an Institution recognized by the University Grants Commission or an equivalent qualification

2) Must possess a P.G. Diploma in Child Psychology and Family Relations of a University Recognised by University Grants Commission or a M.Ed. or B.Ed., from a recognised Institution / **(or) M.Phil Psychology of a recognised University.**

Age Limit : Must not have completed 38 years of age as on 01-08-2008(as per G.O.Ms.No.772 GA (ser. A) Deptt, Dt.09-10-2007). There shall be a relaxation of (5) years for candidates Belonging to SC, ST., and BC's as per rules.

Note:- Relaxation of upper age limit for those who are working on contract basis in APM&HS, by number of years actually they worked on contract basis, subject to a maximum of (5) years and also subject to condition that in no case, the upper age limit should not exceed 43 years.

Fee : Each Application must be accompanied by a D.D. for Rs.100/- (Rupees One Hundred Only) drawn from any Nationalised Bank in favor of the Director of Medical Education, A.P, Hyderabad payable at Hyderabad. SC & ST candidates are exempted from payment of the above fee.

Rule of Reservation : The Rule of Reservation shall be applied wherever Applicable.

Method of Recruitment: Recruitment shall be based purely on merit basis and the following method shall be followed.

For the post of Clinical Psychologist.

- a) 70 % of Marks in qualifying exam
- b) 10 Marks for higher qualification i.e. Ph.d
- c) 5 marks for every 6 (six) months of service on contract basis in Govt. Hospitals subject to a Maximum of 20 marks.

The Merit list will be prepared by adding a, b & c for the post of Child Psychologist.

P.T.O.

Probation: Every person appointed by direct recruitment shall be placed on Probation for period of (2) Years within a continuous period of (3) Years.

Training: Every person appointed by direct recruitment shall undergo training as may be prescribed by Govt. from time to time during the period of probation failing which he shall be discharged from services. Before commencing the period of training the individual shall execute a bond to the effect that he shall serve the Department for a minimum period of (3) years failing which he shall refund the Pay & Allowance paid to him in addition to the amount spent by the Government for his training.

Tests: Every person appointed by Direct Recruitment shall pass 2nd class Language Test in Telugu and Accounts test for Executive Officers within the period of probation.
