In view of the above, the last date of selection process for admission into 1st year of 3 (Three) years General Nursing and Midwifery Training Course and Six months Internship for (Male) & Female candidates for the academic year 2011-2012 in respect of Private Schools of Nursing is extended up to 26.11.2011. No further extension of date is allowed after 26.11.2011.

Hence, all the DM&HOs in the state are requested to take further necessary action in the matter and submit compliance to this office.

Further, all the Principals of Private Schools of Nursing in the state are instructed to complete prescribed theory and clinical hours according to the Indian Nursing Council norms by September, 2012 in view of regular examinations.

ORDER:

In the letters 10th to 15th read above, the Managements of various Paramedical and Nursing Institutions Management Associations have represented that the students who are being admitted in Paramedical and Nursing courses belong to poor, weaker and down trodden SC / ST / BCs., and that they also hail from most Backward Districts in the State and not sound enough to meet the expenditure to complete the course by paying fees under Management quota. In the educational institutions like Polytechnics / ITIs / Jr. Colleges and other Diploma Courses, all the seats in the Institutions are common seats. They have also represented that most of the students are showing interest in joining in these courses and they are not showing interest in paramedical courses. If the existing pattern of 40:60 ratio of seat matrix between Government and Management continues, the enrollment of students into Paramedical and Nursing Courses would be reduced year by year. They have further represented that because of hike in building rents, salaries of the staff and other eventual requirements, like maintenance of Library, Laboratories and providing Infrastructure, they are not able to run the courses in their Institutions.

- 2. Further, they have stated that it is very difficult to recruit the students for Government and Management seats and there would be legal complications in future also because the poor downtrodden students are not able to pay the Management fee and study the courses. Keeping in view of the earlier legal cases regarding payment of the tuition fee under Management seats by poor students, sanction of Scholarships to the Management seats by the Government and also the employment opportunities in paramedical and nursing courses to the poor, downtrodden students, it is necessary to convert all the seats as Common seats instead of Government and Management seats.
- 3. In view of the above circumstances, they have requested the Government to convert all the seats as Common Seats instead of Government and Management seats, as in the case of Junior Colleges, I.T.I's., Polytechnics and other Diploma Courses in the State.
- 4. The matter was referred to Dr. NTR University of Health Sciences, Vijayawada for its comprehensive examination and recommendation in the matter. In the letter 16th read above, the Vice-Chancellor, Dr. NTR University of Health Sciences has reported that a comprehensive review was made regarding the Nursing and Para Medical courses by the Group of Ministers and in regard to seat matrix, it has been felt that in view of the abolition of fee reimbursement to the management quota, it may be appropriate to revise the seat matrix to 60:40 (Government and Management quota) from the existing 40:60.

5. The Government after careful examination of the matter have decided to accept the recommendation of the Vice-Chancellor, Dr. NTR University of Health Sciences and to amend the rules, wherever necessary, revising the seat matrix as 60% for convenor quota and 40% management quota for all Paramedical and Nursing Courses viz., B.Sc.(Nursing), General Nursing and Midwifery, Multi Purpose Health Workers (Female), BPT, B.Sc.(MLT), DMLT and other Paramedical courses w.e.f. the academic year 2011-2012 onwards. Accordingly, the following notification will be published in the issue of Andhra Pradesh Gazette, extraordinary dated:11-11-2011: -
