The Chief information Officer, O/o Director of Medical Education, A.P., Hyderabad is informed that, the Notification for admission into 1<sup>st</sup> year of Three years General Nursing and Midwifery Training Course Male & Female candidates for the academic year 2015-2016 in respect of Govt. & Private Schools of Nursing has been issued. And Post Basic Diploma One Year Course in Government and eligible Private Schools ( those completed APNMC inspection for PBDC) in the State for the year 2015-16 vide 1<sup>st</sup> reference cited.

Further the Nursing Schools Management Association, AP has informed this office vide 2<sup>nd</sup> reference cited that so far 15% to 20% applications have been received for the GNM course in the Private Nursing Schools in the State. B.Sc (N) notification has not yet issued and many students are waiting for B.Sc (N) course admission. The candidates who did not get admission in B.Sc (N) course may join in GNM course. Many students have also not yet received their intermediate certificates from their institutions. The parents are also requesting for the extension the date of admissions. In view of the above, they requested the DME to extend the last date for one month.

In view of the above, the last date for registration of GNM admissions for Private Nursing Schools is postponed from 04.09.2015 to 30.09.2015 and the relevant dates are as follows:

1. Last date for payment of Registration fee is 30.09.2015.
2. Online submission of applications are from 20.07.2015 to 30.09.2015 for Private Schools.
3. Last date for submission of Downloaded applications is 03.10.2015 up to 5.00 P.M. for Convener Quota seats and 08.10.2015 up to 5.00 PM for Management Quota seats.


4. Selection process should be completed by 27.10.2015 for Private Schools by DM&HO.
5. Commencement of classes will be from 02.11.2015

Hence the Chief Information Officer O/o. Director of Medical Education., AP., Hyd is requested to place the said date in the official website of the Director of Medical Education, AP, Hyderabad and also requested to take steps for Online submission of GNM admission applications immediately.
