In the reference Ist cited, the Regional Director of Medical and Health Services, Kadapa has submitted a copy of Proceedings wherein he issued revision of seniority orders in the cadre of PHN(T) between Smt.P.Sumithra Devi, Lecturer of Nursing and Smt.S.Sasikala, Lecturer of Nursing working at O/o the Govt. College of Nursing, RIMS, Kadapa .

In this connection, It is informed that the RDM&HS, Kadapa has finally issued orders that Smt.P.Sumithra Devi ,Lecturer is senior to Smt.S.Sasikala, Lecturer of Nursing, GCON,RIMS, Kadapa as per the merit and appointment order issued by the Regional Director of Medical and Health Services, Kadapa in the cadre of Staff Nurse(Initial Category)for all 45 candidates appointed in Proc.Rc.No.3018/B1/1986 Dt.23.03.1987.

In view of the above final orders was communicated by the RDM&HS, Kadapa that Smt.P.Sumithra Devi is senior to Smt.S.Shasi Kala, so, Smt.P.Sumithra Devi to be assigned seniority No.8 and Smt.S.Shasikala Seniority No.9 in the final seniority list which is enclosed in Annexure-I.

She was promoted as PHN(T) and also regularised in the cadre of PHN(T) as per the available records from the RDM&HS Kadapa. Hence there is no change in the final Seniority list of lecturer s circulated by this office on 20.06.2017.
