In continuation of this office references cited, the re-counting results of 1st, 2nd and 3rd year General Nursing and Midwifery Regular Examinations held in **October'2017** are hereby declared in the annexure enclosed and certain instructions are issued to the Schools which are as follows.

On the request of the Private Schools Management Association, permission was approved and accorded by the Director of Medical Education to give 5 grace marks to the 3rd year students who failed only in one subject as it improves the pass percentage.

It is suggested by the Director of Medical Education to all the Private Nursing Schools to improve the teaching facilities in the schools by way of appointing teaching faculty as per INC norms and make sure that students should attend the clinicals as per syllabus and improve clinical skills. The school authorities have to submit clinical attachment fee receipt, Clinical attendance certificate additionally along with the general enclosures at the time of applying for clinical permissions in the DME office.

Further the private schools are instructed to send at least 3 experienced faculty members for the valuation of answer scripts as there are about 250 private schools and only 8 Government schools in the state to announce the results within the stipulated time.
