I have to inform that this Directorate has Board of Examinations for General Nursing and Midwifery which is conducting General Nursing & Midwifery Examinations, Regular and Supplementary. Every year more than **33477** students are appearing for Regular Examinations and now **35368** students are appearing for Regular August, 2008 Examinations. Further, it is also informed that every year the schools are also increasing and No. of students are also increasing to appear for the examinations.

At present there are 340 schools of Nursing including Nine Govt. Schools of Nursing students are appearing for the General Nursing & Midwifery Examinations, August, 2008 to be held from 28th August, 2008, to 6th October 2008. At present Nine (9) examination centers are existing in Twelve (12) Teaching Hospitals and Medical colleges under the control of Director of Medical Education, A.P., Hyderabad. In the reference 2nd cited the following 5 examination centers are established and conducted the General Nursing and Midwifery Examinations August, 2007 i.e. , Previous Year .
