3) **EDUCATIONAL QUALIFICATIONS:**

MBBS along with P.G Degree or P.G. Diploma in the concerned speciality from a University recognized by Medical Council of India.

4) **AGE:** (As on 01.01.2007)

The minimum and maximum age shall be reckoned as on 01.01.2007 with the relaxations allowed for reckoning duly the maximum age limit as per rules. The candidate should not have completed 40 years of age as on 01-01-2007.

Relaxation will be as follows:

- i. For S.Cs., S.Ts & BCs 5 (Five) years.
- ii. For Ex-service Men 3 (Three) years in addition to the length of service in armed forces.
- iii. Disabled persons 10 (Ten) years.
- iv. However, if sufficient number of candidates are not available, candidates upto 45 years of age will also be considered for recruitment.

EXPLANATION:

The above age limits are subject to a maximum of 45 years for BCs, SCs & STs.

1. After provision of relaxation of age as shown above the age shall not exceed the maximum prescribed
2. Making deductions referred to at S.No. i , ii ,iii the applicant's age shall not exceed the maximum age limit provided for the post.

Note: Relaxation of upper age limit for the Doctors who are working on contract basis in Andhra Pradesh Medical & Health Services, by number of years actually they worked on contract basis, subject to a maximum of (5) years and also subject to condition that in no case, the upper age limit should exceed 50 years.

5) Last date for submission of filled in applications - on or before 5.00 PM of 15th May 2007.

6) Rule of reservation is applicable as per rules in Vogue.
