ORDER:

Government have been providing medical facilities with necessary infrastructure/equipment facilities for various specialised treatments in Government hospitals in the State. There are Government teaching hospitals, Specialist hospitals, District headquarters hospitals, Area hospitals, Primary health centers, Rural dispensaries, Community health centers, in which medical facilities can be availed by Government employees/retired employees and their dependents and other categories of persons mentioned in Andhra Pradesh Integrated Medical Attendance Rules, 1972, for their medical treatment. Simultaneously, medical health and care has been expanded in the State with establishment of many private hospitals with super specialty facilities. With a view of allowing these facilities to the State Government employees /retired employees and their dependents and other categories of persons come under the purview of Andhra Pradesh Integrated Medical Attendance Rules, Government have permitted them to secure treatment in these hospitals with certain conditions. First the facilities available in the Government Hospitals should be availed by the employees and the facilities which are not available can be sought from the super specialty hospitals in the private sector. Accordingly, Government have issued

orders in G.O.Ms.No.38, dated 23.01.1996 recognising seven private hospitals in the State and eight private hospitals out side the State as referral hospitals for the treatment of employees /retired employees and their dependents, subject to the following conditions:-

i) The above private hospitals will be referral hospitals for all types of cases including acute myocardial infarction; acute coronary disease; acute renal failure; severe cases of head and spinal injury, road accident and cases of coma.

ii) Referral of patients to the above private hospitals should be from the Director, Nizam's Institute of Medical Sciences, Hyderabad /Sri Venkateswara Institute of Medical Sciences, Tirupati in respect of above cases, only on a certificate given by them.

2) Subsequently the above conditions have been liberalised and a total of 46 private hospitals in the State and 18 private hospitals out side the State have been recognised as referral hospitals. Many private hospitals are approaching Government for recognition of their hospitals as referral hospitals.

3) In order to take a comprehensive view and to adopt a uniform policy, Government have referred the issue of framing draft guidelines to the Committee constituted for revision of Andhra Pradesh Integrated Medical Attendance Rules, 1972 –vide reference third read above. In the letter sixth read above, the Chairman of the Committee and Director of Medical Education has submitted the draft guidelines to Government.

4) The issue of framing guidelines for recognition of private hospitals as referral hospitals was discussed with representatives of Indian Medical Association, A.P. Private Nursing Homes Association (A.P.N.A.) and some of the corporate hospitals in the meeting held in the conference hall of Director of Medical Education, Hyderabad on 11-01-2005. There was a general agreement on the draft guidelines. Government have reviewed the matter again on 3-03-2005. In the said meeting, it was decided to change two conditions regarding offering free treatment to Below Poverty Line (B.P.L) persons/White Card Holders and adoption of two villages. It was also decided to ask the hospitals to specify what diagnostic and therapeutic services are going to be offered by them to five percent (5%) of their bed strength to the B.P.L. families through a Memorandum of Understanding (M.O.U.) and identify two villages for adoption clearly specifying how they will work in those villages to improve health care and health status of the population in those villages. These two changes will bring in greater specificity and accountability and therefore monitorability.

5) Government after careful consideration of the matter hereby approve the following guidelines for recognition of private hospitals as referral hospitals for the purpose of treatment to State Government employees, their dependents, retired State Government pensioners, and their dependents, M.L.As, Ex.-MLAs and their family members and other category of persons mentioned in Andhra Pradesh Integrated Medical Attendance Rules, 1972 on reimbursement basis:-

1) The private hospital should have bed strength of 100 and more in twin cities of Hyderabad and Secunderabad, Visakhapatnam, Rajahmundry, Vijayawada, Guntur, Warangal and Tirupati.

2) In respect of District headquarters, the bed strength should not be less than fifty (50).

3) The hospital seeking recognition as referral hospital should have facilities for treatments for

all types of diseases and surgeries, the hospital should have the following specialities supported by specialist Doctors, infrastructure facilities, equipment etc:-

(i) Anesthesiology (ii) Cardiology (iii) Cardio thoracic Surgery (iv) Ear Nose Throat (ENT) (v) Emergency Medicine (vi) General Medicine (vii) General Surgery (viii) Nephrology (ix) Neuro Surgery (x) Nuclear Medicine (xi) Obstetrics & Gynecology (xii) Orthopedics (xiii) Pediatrics Pathology (xiv) Plastic Surgery (xv) Pulmonology (xvi) Radiology (xvii) Surgical Gastro enterology (xviii) Surgical Oncology (xix) Urology (xx) Physiotherapy Unit and (xxi) Dialysis Unit.

4) In respect of private hospitals having one or more specialized treatments, they shall be given recognition for that specialty only i.e. Kidney, Heart, Cancer, Neurology and Orthopedic etc.

5) The strength of the specialist doctors, general doctors and para medical staff should be qualified and adequate.

6) They should have own pharmacy, lab facilities and theatre facilities and ambulance for emergency services.

7) They should be able to provide 24 hours service to the patients.

8) Dental Services:-

i) Five in-patient beds, five dental chairs, ambulance facilities, facilities for control of infection, laboratory, equipment, diagnostic facilities, arrangements for "X" - Ray unit etc.

ii) The hospital should be headed by a M.D. specialist in Dentistry services with a minimum of two doctors and ten para medical staff.

9) The private hospitals should also convey their willingness and abide to the following conditions:-

(i) The Hospital should give free treatment for outpatient and in-patient services including diagnostic, surgical, therapeutic and clinical services to the white card holders of the State of Andhra Pradesh or persons below poverty line (B.P.L.) to a minimum of five percent (5%) of bed strength (for inpatient services). The Hospital will enter into a Memorandum of Understanding separately on the exact number of inpatients and outpatients, the types of diagnostic and therapeutic services to be extended. The details of treatment should be properly documented in a register by the hospital.

(ii) The Hospital should give free medical treatment to students of Andhra Pradesh Social Welfare Residential School/Tribal Welfare Residential School/ B.C. Welfare Residential Schools, S.T. Ashram Schools, S.T. Hostels, G.V.V.K. Schools and Maabadi Schools whenever referred by the Principal of the said School, any Govt. Medical Officer, District Referral Committee, District Social Welfare Officer or P.D., I.T.D.A. or any authorised official to be notified by Govt. from time to time.

(iii) The private hospital should adopt at least two villages for providing better medical and health services to the rural people. This includes free diagnostic services, conducting health camps once in every month in the villages. The Hospital will enter into a Memorandum of Understanding indicating the villages identified for adoption. In these villages, the hospital should take all steps to improve the overall health status of the population with special focus in maternal and child health.

(iv) The Hospital shall furnish a monthly return in the following format to the Director of Medical

Education, A.P., Hyderabad.

(v) Referral of patients to the private hospital should be from the Director, Nizam's Institute of Medical Sciences (NIMS), Hyderabad, Director, Sri Venkateswara Institute of Medical Sciences (SVIMS), Tirupati, Superintendents of Government Teaching Hospitals and Superintendents of district headquarters hospitals and Area Hospitals in the State. These Hospitals will first ensure that facilities available with them and other Government hospitals are fully utilised in the first instance, before referring the patients to the private hospitals recognised as referral hospitals.

(vi) The Hospital concerned should charge for all medical/surgical /diagnostic services including major ailments of Heart Bypass surgery, Kidney transplantation, Cancer, Neuro surgery etc., given by them under this scheme, as per the package rates prescribed by Government of India, Ministry of Health and Family Welfare for C.G.H.S, Hyderabad and as adopted by the State Government in G.O.Ms.No.74, H.M.&F.W. (K1) Deptt., dt.15-03-2005 or as may be prescribed by the State Government or the Director of Medical Education from time to time. In respect of dental treatments and Eye ailments, the package rates shall be as prescribed in G.O.Ms.No.74, H.M.&F.W.(K1) Deptt., dt.15-03-2005 and as amended from time to time. The Director of Medical Education/Scrutinising authority shall verify and ensure that the charges levied by the private hospitals are as per the above rates, before certifying the net admissible amount. If the rates of Private hospitals are less than the C.G.H.S. package rates/Government rates as per annexures to the said G.O., the lowest rates of private hospitals shall be accepted for scrutiny and payment.

(vii) A 10% cut shall be imposed on the gross admissible amount within the ceiling limit as certified by the Director of Medical Education, A.P. Hyderabad/ Scrutinising authority in respect of the cases where the patient is admitted in the private hospitals recognised under emergency conditions without referral letter from the hospitals mentioned at clause (v) above. The private hospitals should also accept letter of credit (L.O.C.) from the Departments concerned for giving treatment and also to give treatment on producing Identity card of the employee under emergency circumstances, pending issue of letter of credit.

(viii) The hospital will be inspected in each quarter by a team of Government doctors to be constituted by Director of Medical Education /Superintendent of Government Teaching Hospital/ Superintendent of Government Head Quarter's Hospital to ensure that the diagnostic, surgical, therapeutic services and the overall quality of care in the private hospital are satisfactory. The Director of Medical Education, A.P., Hyderabad or any officer authorised by Director of Medical Education will conduct inspection periodically to verify and ensure that the said private hospital is complying with all the conditions as stipulated above and verify the Registers and make appropriate recommendation to Government through the Director of Medical Education for necessary action.

(ix) The Private Hospitals who desires to come under this scheme should submit the application format as per Annexure to this order along with Memorandum of Understanding to the Director of Medical Education, A.P., Hyderabad and a demand draft for Rs.30,000/- (Rupees thirty

thousand only) from any of the Nationalised Banks drawn infavour of Director of Medical Education, A.P., Hyderabad towards inspection fee.

x) The Director of Medical Education shall constitute a team of medical experts and Accounts Officers to do a random sample detailed scrutiny of the bills reimbursed in favour of Government servants etc for the treatment given to Government employees /retired employees and other categories of persons as per APIMA Rules, 1972. Chartered Accountants can be engaged by Director of Medical Education for this purpose to satisfy that these cases are not over billed compared to others and the services offered to B.P.L. persons. For this purpose, a yearly inspection fee shall be Rs.30,000/- and collected from the hospital concerned.

xi) The Director of Medical Education after getting inspection by an inspection committee headed by not less than Additional Director along with two (2) other specialists of the rank of the H.O.D. of Medical College and after satisfying that the hospital is fulfilling all the conditions and is able to provide quality treatment based on inspection report, the Director of Medical Education will enter a Memorandum of Understanding (MOU) with the Management of the hospital. Thereafter, the Director of Medical Education will issue necessary orders notifying the said hospital as a referral hospital, duly mentioning the conditions, details of M.O.U. and shall also communicate to all the H.O.D.s, Regional and District Officers, All scrutinising/ Supervising authorities, Government, and all other concerned. The Director of Medical Education shall take utmost care in approving the private hospitals as referral hospitals. He shall also get it published in the News papers.

xii) The private hospitals which have already been recognised should also follow these guidelines to continue their recognition within a period of one month from the date of issue of this order, duly applying to the Director of Medical Education, A.P., Hyderabad.

(xiii) The recognition so accorded will be valid for a period of three years only from the date of recognition and the Hospital should submit application before the Director of Medical Education, A.P., Hyderabad seeking renewal within three months before the date of expiry of the said period, together with a demand draft for Rs.30,000/- (Rupees thirty thousand only) from any nationalized bank drawn in favour of Director of Medical Education, A.P., Hyderabad towards application form and inspection.xiv) The permission accorded to the hospital is liable for cancellation and such other action as deemed fit, including de-recognition of the hospital and initiate criminal action as per law against the hospital, whenever the State Government forms the opinion based on inspection or enquiry into the allegations that the said Private Hospital is not providing treatment to the State Government employees/ retired employees and their dependents etc. as stipulated above and violates the conditions mentioned therein, and indulge any irregularities in respect of excess/ bogus claims, cheating the patient or Government or resorting to any unlawful activities etc, after giving fifteen (15) days notice to the hospital and pass appropriate orders, after considering the representation, if any, offered by the said Hospital.

6. The Director of Medical Education, A.P., Hyderabad shall take necessary further action in the matter accordingly.
