VACANCIES & EDUCATIONAL QUALIFICATIONS:

- Applications are invited from the eligible candidates for the post of Tutors in the Government Medical Colleges and Teaching Hospitals under the Directorate of Medical Education.
- 2. Recruitment is on **contract basis** for a period of one year initially.
- 3. Recruitment shall be as per the service rules issued in the Govt. Memo. No.2341470/HMFW-A/2024, Dt.10.04.2024 HM&FW Department (D1) Dt.07.02.2024, GO.Ms.No.154 HM&FW Dt.27.06.2002, GO.Ms.No.222 HM&FW Department Dt.15.12.2023 and Teachers Eligibility Qualifications in Medical Institutions Regulations issued by NMC from time to time.
- 4. Total Number of Vacancies: **158** (One hundred and fifty eight)
- Details of specialty-wise vacancies are at ANNEXURE NO. I to the notification.Vacancies may be increased / decreased

6. EDUCATIONAL QUALIFICATIONS:

- Candidates should have passed MBBS Degree examination or its equivalent examination (MCI Act, 1956 as amended from time to time and from a College recognized by the Medical Council of India).
- Shall be registered with AP Medical Council In case registered in medical council other that AP Medical Council, candidates shall register in APMC before joining in the post
- 7. Remuneration of Rs.70,000/- p.m

8. **SELECTION PROCESS**:

- a) Total Marks 100.
- b) 75% Marks will be allocated against marks obtained in the qualifying examination i.e., Aggregate of Marks obtained in all the years in the qualifying examination.
- c) In case of Foreign Degrees for Aggregate of Marks of 75%:
 - a) The candidates who have passed the MBBS degree in Foreign Universities, the 75% aggregate marks weighatage is given as per the following formula.

b) A Grade / Excellent - 60% x 75 = 45

c) B Grade / Good - 55% x 75 = 41.25

d) C Grade / Satisfactory - 50% x 75 = 37.50

The percentage of marks awarded in Foreign Universities, those marks shall be converted as Grades as follows.

Percentage of	Converted	Marks to be awarded
marks obtained	Grade	for recruitment
80% to 100%	A Grade	60% x 75 = 45
65% to 80%	B Grade	55% x 75 = 41.25
Below 65%	C Grade	50% x 75 = 37.50

- d) In certain Foreign Universities Degrees shown as academic hours / amount of hours / ECIS Ranks / National grade / Study hours / credits/ Grade points GPA/pass etc., In such cases, where marks/grades are not clearly shown, the Grade C with 50% as maximum marks will be awarded.
- e) Marks awarded for languages shall not be considered for weightage of aggregate marks.
- f) Upto 10 marks @ 1.0 marks per completed year after acquiring requisite qualification as mentioned in the pass certificate. Weightage will be reckoned up date of notification as per Govt. Memo No.4274/D1/2013 HM&FW (D1) Dept., Dt.10.07.2014.

- g) Contract service can be calculated from the date of completion of Graduation (Requisite qualification) only.
 - 2.5 marks per six months in Tribal Area.
 - 2 marks per six months in Rural Area.
 - 1 mark per six months in Urban Area
- h) Contract Service Certificate issued by the competent authority and signed by the Superintendent of Government Teaching Hospital / DM & HO / DCHS shall be submitted for claiming the contract weightage. Contract weightage will not be awarded, in case of non-submission of signed certificate from the above authorities.
- i) Weightage will be awarded upto 15 Marks for the candidates who rendered their services on contract basis for COVID-19 duties.
- j) Contract service will be reckoned up to the date of notification as per Government Memo No. 4274/D1/ 2013, HM&FW (D1) Dept., dt.10.07.2014.
- k) Spells of services will also be considered for weightage marks.
- I) Contract weightage will be awarded as per G.O.Rt.No.211, HM &FW(B2) Dept., Dated 08.05.2021 and G.O.Rt.No.7 HM&FW(B2) Department Dt.06.01.2022 read with circularno.03/ CHFW/2022, dated 11.02.2022 of CHFW.
- m) Following documents to be submitted to claim COVID-19 weightage:
 - 1. Appointment order for COVID-19 management.
 - 2. Monthly attendance certificates.
 - 3. Bank statement indicating payment of monthly remuneration along with COVID-19 weightage service certificate.

- 4. Service certificate from the competent authority in the prescribed proforma (DMHO/DCHS/Medical Superintendent in case of GGH).
- Covid contract weightage will not be awarded in case of non-submission of any of the above certificates from m (1) to m (4).

9. **AGE**:

- i. OC candidate should not have completed 42 years as on date of Notification
- ii. EWS/SC/ST/BC candidates should not have completed 47 years as on date of Notification
- iii. Differently Abled person should not have completed 52 years as on date of Notification
- iv. Ex-servicemen should not have completed 50 years as on the date of Notification
- v. Rule of Reservation will apply as per A.P State and Subordinate Service Rules in force

10. HOW TO APPLY:

- 1. Applications shall be submitted online at http://dme.ap.nic.in from 04.05.2024 to 15.05.2024 till 11.59 pm.
- 2. The candidates shall have to pay the application fee of Rs.1000/- for OC and Rs.500/- for BC, SC, EWS, ST, Ex-service men and Differently abled candidates.
- 3. Payment shall be done in online Mode only.
- 4. Candidates who are Local to Andhra Pradesh Only are eligible.
- 5. Interested candidates are requested to visit the website https:<u>dme.ap.nic.in</u>. Candidates shall submit the application online uploading following certificates in support of their claims in the application
 - a. Latest passport-size photo*
 - b. SSC Certificates (proof of date of birth)*
 - c. Intermediate certificate*
 - d. MBBS Degree Certificate*
 - e. MBBS Degree Complete Marks Memos
 - f. AP Medical Council Registration Certificate*
 - g. Candidates, who claim for VH/MH/HH/OH vacancy, must submit Disability Certificate to that extent, issued by concerned medical board

or SADAREM.

- h. Caste Certificate in case of SC/ST/BC or Social Status (for candidates claiming EWS) Certificate issued by Competent authority. If caste certificate is NOT submitted, then such candidate is considered as OC.
- i. Meritorious sports certificates in case of claiming the sports quota.

11. <u>IMPORTANT INFORMATION TO CANDIDATES</u>:

- A. The decision of the department regarding acceptance or rejection of the candidature, conduct of counseling and at all consequent stages culminating in the selection or otherwise of any candidates shall be final in all respects and binding on all concerned under the powers vested with.
- B. The department also reserves its right and modify regarding time and conditions laid down in the notification for conducting the various stages of selection duly intimating the details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.
- C. The recruitment is subject to outcome of any O.As / W.Ps pending before the Court and likely to arise in the matter.
- D. Member Secretary, APMSRB / Director of Medical Education reserves every right to cancel the Notification / alter / modify/amend any condition laid down in the Notification for final selection and also number of posts notified.
