- Sub: Andhra Pradesh Para Medical Board- Certain Paramedical Institutions running courses without Government Permission and with certificate of Recognition issued mentioning WP No.29993 of 2011 - Certificate of Recognition Cancelled- Orders Issued -Reg.

The New AP Paramedical Board was constituted vide GOMS No. 144 HM & FW(G2) Dept., dated 13/11/2015. The Board has invited the managements to submit self Assessment Reports with relevant documents and most of the institutions submitted the same. On scrutiny of the above Board has identified certain institutions are running additional courses without Government permission and with Certificate of Recognition issued mentioning WP No.23999 of 2011 and CC No.1082 of 2012.

On verification of the records, it is noticed that the Hon'ble High Court passed the said order in WP No. 29993 of 2011 and CC No. 1082 of 2012 in favour of S.V.S.S.Mahila Vidya Samstha, Tanuku, West Godavari District to establish Sri Karuna MPHA Training Centre, Tanuku, West Godavari Dist to start MPHA(M) Course, in the light of the facts and circumstance of that particular case and the same was disposed including contempt on 21/11/2012 as the orders were complied.

As the orders issued by Hon'ble High Court in WP No.29993 of 2011 cited at 2nd reference, are applicable only to S.V.S.S.Mahila Vidya Samstha, Tanuku, West Godavari District to establish Sri Karuna MPHA Training Centre, Tanuku, West Godavari Dist, All the other institutions running additional courses without Government Permission were issued show cause notice why the certificate of recognition to be withdrawn. Most of the managements not responded inspite of receipt of showcause notice.

The matter was placed before Executive committee meeting on 27/07/2016 and after elaborate discussion it is resolved to cancel the certificate of recognition issued by the then Board to the Paramedical Institutions mentioning WP No.29993 of 2011 as it is not applicable to other institutions.

In view of the above and keeping the hardship facing by the students and in the interest of students community all such certificates issued earlier mentioning WP No.23999 of 2011 and CC No.1082 of 2012 are hereby cancelled with immediate effect.

The managements of Paramedical Institutions of Andhra Pradesh are hereby instructed to surrender all the certificates of Recognition issued mentioning the WP No. 23999 of 2011 and CC No.1082 of 2012 to the Secretary, AP Paramedical Board within a week for taking further course of action.
