- 6) No Charges & No Dues Certificate.
- 7) Copies of the punishment / charges awarded, if any.

- Vacancy Position of Professors for all the specialities
- > Particulars of presently working Professors in all specialities belonging to SC / ST community along with their date of Retirement.
