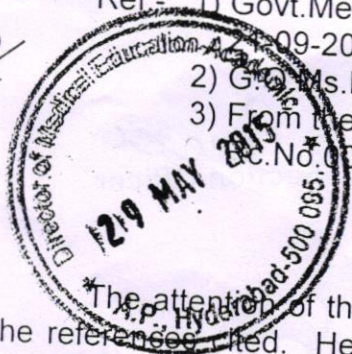

The attention of the Director of Medical Education, A.P., Hyderabad is invited to the references cited. He is informed that orders were issued in G.O. 2nd cited giving weightage of marks for recruitment of Assistant Professors under the control of Director of Medical Education through Departmental Selection Commission.

2. The Director of Medical Education, A.P., Hyderabad in his letter 3rd cited has requested the Government to adopt the certain clarifications issued by the Government vide Government Memo 1st cited for ongoing recruitment of Assistant Professors for Post PG the service rendered in State Government Institutions.

3. Government after examination, hereby permit the Director of Medical Education, A.P., Hyderabad to take further necessary action on the following points while taking up recruitment of Assistant Professors for Post PG the service rendered in State Government Institutions:-

- i) The contractual service put up by the Medical Officers who were appointed with financial concurrence at the Government level and where services was discontinued but not on account of any fault on their part, will be counted for weightage of marks;
- ii) The contractual service of those Medical Officers who have been appointed on contract basis without prior financial concurrence of Government of Andhra Pradesh but are presently working in APSACS, RNTCP and Mobile Epidemics and MCH team in tribal and Vulnerable areas under NRHM will be counted for weightage of marks;
- iii) The contractual service put in by the doctors who have been appointed on contract basis at RIMS Hospitals by the DSC and who are drawing salary under 310/311-Grants will be counted for weightage of marks; and
- iv) The contractual service put in by the doctors who have been appointed on contract basis in the ESI Hospitals under Director of Insurance Medical Services by the DSC and who are drawing salary under 300 – Grants will be counted for weightage of marks.
- v) The contractual service rendered in all programmes / schemes under the control of Commissioner of Health & Family Welfare / Director of Public Health & Family Welfare, A.P., Hyderabad / Commissioner, A.P. Vaidya Vidhana Parishad, Hyderabad in present and erstwhile Andhra Pradesh State, excluding compulsory Government service and regular Government service will be counted for weightage of marks.
- vi) The contract service rendered in RIMS Institutions, NIMS and SVIMS will be counted for weightage of marks.
