In the reference 3<sup>rd</sup> and 5<sup>th</sup> cited, provisional integrated seniority list of Assistant professors has been communicated duly offering objections if any. After receipt of the provisional integrated seniority list, a W P No. 24647/2020 has been filed by 14 Assistant professors who were appointed through Lateral Entry with a pray to place them in the Final Seniority List by taking their date of appointment into consideration with all consequential benefits and the Hon'ble High issued orders on 27.1.2021 as follows :

**"the respondents are directed to prepare and release the final seniority list within**

**four (4) weeks from today, considering the objections filed by the Petitioners, if**

**filed within the time fixed for submission of those objections."**

**Some Assistant Professors belongs to the Specialty of Anatomy, have submitted certain objections on the Provisional Integrated Seniority list by objecting the following points:**

- (i) **The Assistant Professors those who were appointed by way of Lateral Entry have requested for rectification of the seniority as per date of joining by pointing out the clause mentioned in their appointment orders that** their place of seniority fixed below the place of Assistant Professors appointed by way of Direct Recruitment is not correct and requested to rectify the same as per date of joining in to service.

Accordingly, their objection has been examined as per the rule position vide G.O.1<sup>st</sup> cited duly observing rule 33, 34 and 36 A.P. State and Subordinate Service Rules, 1996 and Supreme Court judgement dt. 19.10.2010 and the final integrated seniority list is issued by taking the date of joining into Government Service.

- (ii) **Some Assistant Professors have requested to correct their service particulars i.e., Name, Date of Birth, Date of Joining etc. and**

**accordingly as per the proof provided by them, the same have been corrected.**

- (iii) The point of objection raised regarding the speciality of Anatomy that the qualification of Assistant Professors with M.Sc., Ph.D., degrees can not be considered for seniority raised by the Assistant Professors with the qualification of MD Anatomy, has also been examined. As per Annexure II para 9 (b)(1) of G.O. 1<sup>st</sup> cited, M.Sc., Ph.D., is requisite qualification for the post of Assistant Professor other than M.D Anatomy.

Accordingly, the Provisional Integrated Seniority List of Assistant Professors of **Anatomy** who were appointed in the years of 2014, 2015 and 2017 by way of Direct Recruitment and Lateral Entry issued vide references 3<sup>rd</sup> and 5<sup>th</sup> cited is hereby finalized duly examining the objections as per Rule position discussed above duly publishing the Integrated Seniority List of Assistant Professors in the DME Website i.e. <http://dme.ap.nic.in>
