It has been proposed to prepare seniority list from feeder categories for the posts of Dietician (G) in the institutions under the control of the Director of Medical Education, Andhra Pradesh by the eligible in-service candidates by way of appointment by transfer from any other category governed by rules in terms of Government orders mentioned in the reference cited for the panel year 2020-21.

### DIETICIAN : As per G.O.Ms.No.154, HM&FW (A2) Dept., dt. 4.5.2002.

As per G.O.Ms.No.154, HM&FW (A2) Dept., dt. 4.5.2002 the method of appointment to the cadre of Dietician is as follows:

- (i) By appointment by transfer of qualified Head Nurses from the A.P.Nursing Subordinate Service.
- (ii) If no qualified person is available for appointment by method (i) above, by direct recruitment.

The eligibility to the cadre of Dietician is as follows:

- (i) Must possess a B.Sc., Degree of a University in India established or incorporated by or under a Central Act, Provincial Act or a State Act or an Institution recognized by the University Grants Commission or an equivalent qualification; and
- (ii) Must have passed one year course of Diploma in Applied Nutrition and Dietetics from a recognized Institution.

Government vide G.O.Ms.No.232, HM&FW (M1) Dept., dt. 15.10.2009 have issued the following amendment:

# AMENDMENT

In Annexure – I of the said rules, in the table in Column (2) against the post of Dietician at S.No.12, for item (i) the following shall be substituted, namely:

"(i) By appointment by transfer of qualified Head Nurses from the Andhra Pradesh Nursing Subordinate Services and qualified candidates from any of the categories in Andhra Pradesh Medical Sub-ordinate Services and Andhra Pradesh Public Health Sub-ordinate Services".
