It has been proposed to prepare seniority list from feeder categories for the posts of Biochemist (G) in the institutions under the control of the Director of Medical Education, Andhra Pradesh by the eligible in-service candidates by way of appointment by transfer from any other category governed by rules in terms of Government orders mentioned in the reference cited for the panel year 2022-23.

**BIOCHEMIST : As per G.O.Ms.No.154, HM&FW (A2) Dept., dt. 4.5.2002 and subsequent
Amendment of G.O.Ms.No.22, HM&FW (M2) Dept., dt. 28.01.2006**

As per G.O.Ms.No.154, HM&FW (A2) Dept., dt. 4.5.2002 the method of appointment to the cadre of Biochemist is as follows:

- (i) By appointment by transfer of qualified Non Medical Assistant (Non-Gazetted) / Junior Analyst / Lab Technician and Non Medical Demonstrator in the category of Demonstrators from a common Seniority list.
- (ii) If no person is available for appointment by method (i) above, by Direct Recruitment.

The eligibility to the cadre of Biochemist (G) is as follows:

- (iii) Must possess a M.Sc., Degree in Bio-Chemistry of a University in India established or incorporated by or under a Central Act, Provincial Act or a State Act or an Institution recognized by the University Grants Commission or an equivalent qualification.

Therefore, all the Superintendents of the Teaching Hospitals & Specialty Hospitals, Principals of Medical Colleges, Principals of Dental Colleges & Principals of Nursing Colleges, under the control of the Director of Medical Education, A.P., Vijayawada and all the Regional Directors of Medical & Health Services and all the District Medical & Health Officers in the state are requested to obtain and furnish the particulars of qualified and willing candidates in the Proforma mentioned below so as to reach this Office on (or) **before 23-11-2022 positively.**

It has been observed that the applications of the in-service candidates received from the institutions need to be completed in some respect, and also, in some cases, applications need to fulfill the eligibility criteria for the post applied for. Even the applications of unqualified candidates are being forwarded for consideration. In order to remove any ambiguity in this regard and to ensure consistency and uniformity in the matter across, the service rules have been framed in the G.O.Ms.No.154, HM&FW (A2) Dept., dt. 04.05.2002 and G.O.Ms.No.22, HM&FW (M2) Dept., dt. 28.01.2006.

The instructions contained in the aforesaid circular must be followed scrupulously by the officers concerned while processing the applications of the in – service candidates for promotion to the post of Biochemist (G).

The sole responsibility lies with the verification officer. Any deviation in the instructions will be viewed seriously.
