Sub :Estt. – DME,A.P,VJA – Applications invited from the eligible in-service candidates to prepare seniority list of Dietician (G) in the institutions under the control of the Director of Medical Education, A.P., Vijayawada for the panel year 2022-23- Circular issued – Regarding

It has been proposed to prepare seniority list from feeder categories for the posts of Dietician (G) in the institutions under the control of the Director of Medical Education, Andhra Pradesh by the eligible in-service candidates by way of appointment by transfer from any other category governed by rules in terms of Government orders mentioned in the reference cited for the panel year 2022-23.

As per G.O.Ms.No.154, HM&FW (A2) Dept., dt. 4.5.2002 and amendment in G.O.Ms.No.232, HM&FW (M1) Dept., dt. 15.10.2009 the method of appointment to the cadre of Dietician is as follows:

i) “(i) By appointment by transfer of qualified Head Nurses from the Andhra Pradesh Nursing Sub-ordinate Services and qualified candidates from any of the categories in Andhra Pradesh Medical Sub-ordinate Services and Andhra Pradesh Public Health Sub-ordinate Services”.

ii)If no qualified person is available for appointment by method (i) above, by direct recruitment

The eligibility to the cadre of Dietician is as follows:

iii)Must possess a B.Sc., Degree of a University in India established or incorporated by or under a Central Act, Provincial Act or a State Act or an Institution recognized by the University Grants Commission or an equivalent qualification; and

iv)Must have passed one year course of Diploma in “Applied Nutrition and Dietetics” from a recognized Institution.

Therefore, all the Superintendents of the Teaching Hospitals & Speciality Hospitals, Principals of Medical Colleges, Principals of Dental Colleges & Principals of Nursing Colleges, under the control of the Director of Medical Education, A.P., Vijayawada and all the Regional Directors of Medical & Health Services and all the District Medical & Health Officers in the state are requested to obtain and furnish the details of candidates who fulfill the above qualifications in the Proforma mentioned below so as to reach this Office on (or) **before 05 -07-2023 positively.**
