Sub:- Nursing Education – Board of Examination for General Nursing and Midwifery (BEGNM) –General Nursing and Midwifery Examinations May,2012 (Supplementary) – Certain instructions issued.

Ref:- 1.This office letter Rc.No. 306/NE.B/2012 dated: 20.04.2012.

In continuation to this office GNM Exam. Notification issued vide reference cited, the following instructions are issued.

1. OLD REGULATIONS STUDENTS

As per the instructions issued in this office Rc.No.39132/NE.B/2011, dated 3.11.2011, **this GNM Exams (Supplementary), May,2012 is the last chance for old regulation students for appearing in Old syllabus.** Other wise, they have to appear for New Regulation syllabus from Regular GNM Examinations, August, 2012.

2.ANM CANDIDATES STUDYING GNM COURSE

The ANM qualified students who admitted in GNM course and those who have completed two and half years training are eligible for appearing 3rd year GNM examinations. They have to fulfill the INC eligibility conditions for appearing examinations. They are directed to submit manual applications for appearing GNM Examinations, May, 2012 while enclosing the following documents.

- a) Photo copy of ANM Certificate.
- b) Photo copies of previous year GNM marks memos.
- c) Internal Marks

3. CANDIDATES WHOSE HALL TICKET NO. STARTS WITH 06 & 07.

The candidates whose Hall ticket Nos. starts with 06 & 07, who are not able to upload the applications through online, they are directed to submit the manual applications along with photo copies of the previous years marks memos and internal marks without fail.

4.INC REGULATIONS FOR ADMISSION TO EXAMINATIONS

The following rule of Indian Nursing Council at Page No.37, under eligibility for admission to examinations are reiterated.

- C. a)** If a student fails in one theory paper/practical, she/he may be allowed to proceed to the next year of study, she/he will sit for a supplementary examination held subsequently in the failed subject/practical. If she/he fails to clear supplementary examination she/he shall be allowed to sit again along with her next year annual examination.
- b)** If a student fails in two or more papers or practical she/he will not be allowed to proceed to the next year. She/he shall sit for supplementary examination in the failed subjects/practicals only but shall be eligible for the next year's examination after one academic year from the date of passing the last examination.
- c)** No candidate of category (a) shall be allowed to proceed to third year (higher class), unless she/he has passed in the subjects of the previous year (backlog to the second year)

In view of the above, all the Principals of the Government Schools of Nursing of the Scrutinizing centres are requested to accept the above applications duly verifying the eligibility criteria as per rules.
