It is informed that, in the reference 1st cited, notification for admission into 1st year of Three years General Nursing and Midwifery Training Course and Six months Internship (for Male & Female candidates) for the academic year 2012-2013 for Government and Private Schools of Nursing has been issued and the last date for submission of online applications has been fixed as 9.8.2012. In the reference 2nd cited, the last date has been extended up to 21.8.2012.

In the reference 2nd and 3rd cited, the Associations of Private Nursing Schools, A.P., Hyderabad has requested for extension of last date for submission of online applications since they got less number of admission application forms.

After careful examination, it is decided to revise the schedule for the admissions of General Nursing & Midwifery course into Private Schools of Nursing in the State which is as follows:

1. Last date for payment of Registration fee is **10.09.2012.**
2. On line submission of admission application forms through website **10.09.2012 by 5 P.M.**
3. Submission of Downloaded applications at respective DM&HOs is up to **10.09.12 by 5.00 P.M.** in respect of Convener quota in Private schools of Nursing.
(For Management seats the last date is extended up to 30.9.2012 by 5.00 P.M.)
4. Selection process should be completed for Convener quota by **25.09.2012** by respective DM&HOs without fail.
5. Commencement of classes will be from **01.10.2012.**

Further, it is also informed that, **No more extension of above dates will be accepted.** All other details regarding eligibility and other criteria remain same as per notification issued previously in the reference 1st cited.

5. Commencement of classes will be from **01.10.2012.**
