In the reference 1st cited this office have issued admission notification for General Nursing and Midwifery Course (3 years) for the Academic year 2019-2020 batch which is being imparted in Government and Private Schools of Nursing in the state and Post Basic Diploma One Year Course in Government and eligible Private Schools (those completed APNMC inspection for PBDC) in the State for the year 2019-20.

In the reference 2nd cited, the Nursing Schools Association have represented that the many seats are vacant and many students are waiting for BSc(N) admission counseling and the students who didn't get the seat in BSc(N) will join in GNM Course and requested the DME to extend the dates. Accordingly, the DME, A.P Vijayawada has considered the representation and the last date for payment of registration is extended up to 17-10-2019.

Further in the reference 3rd cited, Nursing Schools Management Association A.P, Vijayawada has again given another representation to the DME stating that there are 267 nursing schools permitted for admission this year with approximate 13,350 seats. Out of the above, 9551 candidates have applied still approximately 3,800 seats were left over. BSc counselling has not yet started and the candidates who didn't get seats will join the GNM course. In view of the above submission, the Nursing Schools management association requested to extend the date up to 31-10-2019.

Keeping in view of the request made by the Nursing Schools Association, AP., the admission schedule is revised as follows:

1. Last date for payment of Registration fee 31.10.2019 .
2. Online submission of applications are up to 02.11.2019 for Govt. Schools and Private Schools.
3. Last date for submission of Downloaded applications is 04.11.2019 up to 5.00 P.M. for Govt. Schools of Nursing.
4. Last date for submission of Downloaded applications is 04.11.2019 up to 5.00 P.M. for Convener Quota seats and Management Quota seats.
5. Selection process should be completed by 08.11.2019 for Govt. Schools and Private Schools by DM&HO.
6. Commencement of classes will be from 15.11.2019.

For further details, contact concerned Superintendents Government General Hospital, attached with Government School of Nursing, in respect of Government Schools of Nursing, and contact concerned District Medical and Health Officer, in respect of Private Schools of Nursing. Further, all the DM&HO's are requested to upload the selection list of GNM students in the DME website i,e within one week as per the instructions of Indian Nursing Council, New Delhi.

Hence the Chief Information Office, O/o Director of Medical Education, A.P, Vijayawada is requested to place the said dates in the official website of the Director of Medical Education, A.P, Vijayawada and also requested to take steps for online admission applications immediately.
