In the reference 1<sup>st</sup> cited, this office have issued admission notification for General Nursing and Midwifery Course (3 years) for the Academic year 2021-2022 batch which is being imparted in Government and Private Schools of Nursing in the state.

In the reference 2<sup>nd</sup> and 4<sup>th</sup> cited, General Secretary, Andhra Pradesh Nursing Institutions Management Association have represented to the DME for extension of dates two times. Considering the requests made by the AP Nursing Institutions Management Association, DME has extended the dates for Admissions in to GNM two times vide reference 3<sup>rd</sup> and 5<sup>th</sup> cited.

Further in the reference 6<sup>th</sup> cited, General Secretary, Andhra Pradesh Nursing Institutions Management Association has given another representation to the DME requesting to extend the admission dates third time stating that many seats are still vacant in many schools.

Keeping in view of the request made by the General Secretary, Andhra Pradesh Nursing Institutions Management, the admission schedule is revised as follows:

1. Last date for payment of Registration fee is extended up to 02.12.2021.
2. Online submission of applications is extended up to 06.12.2021 for Govt. Schools and Private Schools.
3. Last date for submission of Downloaded applications is 06.12.2021 up to 5.00 P.M. for Govt. Schools of Nursing.
4. Last date for submission of Downloaded applications is 06.12.2021 up to 5.00 P.M. for Convener Quota seats and Management Quota seats it will be 06.12.2021 up to 5 P.M
5. Selection process should be completed by 10.12.2021 for Govt. Schools and Private Schools by DM&HO.
6. Commencement of classes will be from 15.12.2021.
