In the reference 1st cited this office have issued admission notification for General Nursing and Midwifery Course (3 years) for the Academic year 2020-2021 batch which is being imparted in Government and Private Schools of Nursing in the state and Post Basic Diploma One Year Course in Government and eligible Private Schools (those completed APNMC inspection for PBDC) in the State for the year 2020-2021. The same was extended upto 30-11-2020 in the reference 3rd cited.

In the reference 10th cited, General Secretary, A.P. Nursing Institutions Management Association Guntur represented that even the convener seats are not yet filled in many schools and seats are vacant. B.Sc (N) notification is not yet issued and candidates are waiting for B.Sc (N) notification, those candidates who did not get seat in B.Sc (N) will join in GNM course. Hence he has requested to extend the date of admissions since the INC has also extended the date for admissions for all Nursing Programmes till 28-02-2021.

Keeping in view of the request made by the Nursing Schools Association, AP., and Indian Nursing Council notification in reference 5th cited, the admission schedule is revised as follows:
