In the reference 1<sup>st</sup> cited, the final Integrated Seniority list of Nursing Tutor Gr II / PHN (T) / Staff Nurse was published by the Director of Medical Education, A.P., Vijayawada and accordingly promotions were awarded to vide Rc.No.9218/NA/2017, dt. 10.1.2019 to the cadre of Lecturer of Nursing from the cadre of Nursing Tutor Gr II / PHN(T) / Staff Nurse as per the provision laid down in G.O.Ms.No.101, HM&FW (M1) Dept., Dt. 4.4.1997.

In the reference 2<sup>nd</sup> cited, Government have issued orders to review the Integrated Seniority list of Staff Nurses for the panel year 2018-19 as per their date of joining under Rule 34,33(a) and Rule 2 of A.P.S.S.S. Rules, 1996 and on the orders of Hon'ble High Court dt. 25.6.2019 in W.P.No.6001/2019 on examining the appeal of the petitioner viz..., Smt. S.Kezia, Staff Nurse with the following guidelines.

- (i) Issue direction to the RDM&HS, Visakhapatnam to issue revised orders declaring the probation of the Staff Nurses of Visakhapatnam Zone mentioned at Sl.Nos. 6,9,10, 13 & 14 in the Integrated Seniority list, on the date of completion of two years period from the date of their joining in the said post as per the rules 16 (C) of APSSS Rules, 1996 and furnish the revised dates of probation to the Director of Medical Education, A.P., Vijayawada for preparation of Revised Integrated Seniority list of Staff Nurses, duly following the required procedure as per rules in vogue.
- (ii) Revise the Integrated Seniority list of the Staff Nurses for the panel year 2018-2019 by taking into consideration of the date of joining as provided in the A.P. State and Subordinate Services Rules, 1996 and date of probation duly following the required procedure as per rules in vogue; and
- (iii) Thereafter, conduct review DPC for the panel year 2018-2019 by taking the Integrated Seniority List of the Staff Nurses prepared as per the date of joining and issue promotion orders to the eligible Staff Nurses as Lecturer of Nursing, subject to availability of vacancies.

In the reference 3<sup>rd</sup> cited, the Integrated Seniority list of Staff Nurses has been reviewed and issued provisional Integrated Seniority list as per the orders of the Government vide reference 2<sup>nd</sup> cited duly calling objections if any .

In the reference 4<sup>th</sup> cited, certain objections have been received on the reviewed Provisional Integrated Seniority list of Staff Nurses vide reference 3<sup>rd</sup> cited . The objections

received have been examined and rectified according to feasibility under the provision laid down in A.P.S.S.S Rules, 1996.

By the time finalizing the Revised Provisional Inter-se-Seniority list duly attending the objections raised by some individuals in the list, some individuals filed cases in the Hon'ble High Court as mentioned vide references 5<sup>th</sup> to 10<sup>th</sup> cited .

In the reference 5<sup>th</sup> cited, the Hon'ble High Court has kept in abeyance the promotions to the eligible Staff Nurses as Lecturers of Nursing .

In the reference 6<sup>th</sup> cited, Smt. S.Kezia, Staff Nurse GGH, Kurnool filed a case in High Court and the Hon'ble High Court issued directions to the DME to implement the orders dt. 24.08.2020 passed by the 2<sup>nd</sup> respondent on the appeal of the petitioner within four weeks from the date of issuance of orders dt. 29.12.2020.

In the reference 7<sup>th</sup> cited, Smt. B.R.Leelavathi and Smt. G.Manjuladevi Staff Nurses have filed a case in Hon'ble High Court with a request to suspend the operation of references 2<sup>nd</sup> and 3<sup>rd</sup> cited and accordingly, the Hon'ble High Court have issued orders dt. 9.3.2021 by directing the respondents to consider the representations of the petitioners by taking into consideration of the vacancies arose prior to expire of the panel year 2018-19. Thereby, the petitioners representation has been considered and issued speaking orders informing them that there is kept in abeyance orders on the operation of the references 2<sup>nd</sup> and 3<sup>rd</sup> cited and rejected their request to promote them as Lecturers of Nursing at this juncture. Accordingly, the petitioners filed contempt of court in CC.No.842/2021.

In the reference 8<sup>th</sup> cited , Smt. S.Kezia Staff Nurse filed Contempt case in W.P. 6<sup>th</sup> cited for non implementation of the orders dt. 29.12.2020 as the interim orders in W.P.No. 50/2021 have not been further extended.

It is submitted that the matter of existing status of non extension of the Interim Orders dt. 18.1.2021 in the reference 5<sup>th</sup> cited has been discussed with the Government Pleader and it has not been found the orders if any on the extension of Interim Orders dt. 18.1.2021.

In view of the above, the proceedings issued vide reference 3<sup>rd</sup> cited as per the orders of the Government vide 2<sup>nd</sup> cited is hereby finalized after review of integrated seniority list of Staff Nurses 2018-19.
