In the reference 1st cited, this office have issued admission notification for General Nursing and Midwifery Course (3 years) for the Academic year 2022-2023 batch which is being imparted in Government and Private Schools of Nursing in the state and extended the dates for admission vide references 4th and 7th cited.

In the reference 8th cited, the General Secretary, Andhra Pradesh Nursing Institutions Management Association have given another representation to the DME for extension of dates. In the representation he informed that BSc (N) counseling has not yet completed and the candidates who did not get seats in BSc (N) course will join the GNM Course and they will not lose one academic year and requested to extend the dates till 31-12-2022 for payment of Registration fee and online submission of Applications.

In the reference 9th cited, Indian Nursing Council, New Delhi has extended the last dates for admission to GNM & ANM programme for the academic year 2022-2023 till 31st December -2022.

In view of the above the admission schedule is revised as follows:

1. Payment of Registration fee is extended up to 27-12-2022.
2. Online submission of applications are extended up to 27-12-2022 for Govt. Schools of Nursing.
3. Last date for submission of downloaded applications is extended till 27 -12-2022 up to 5.00 P.M. for Govt. Schools of Nursing.
4. Online submission of applications and submission of downloaded applications are extended up to 27- 12-2022 till 5.00 P.M. for private schools Convener Quota.
5. Online submission of applications and submission of downloaded applications are extended up to 27-12-2022 up to 5.00 P.M. for private schools Management Quota.
5. Selection process should be completed by 31 -12-.2022 for Govt. Schools and by 31-12-2022 for Private Schools by DM&HOs.
6. Commencement of classes will be from 02 -01-2023.

For further details, contact concerned Superintendents Government General Hospital, attached with Government School of Nursing, in respect of Government Schools of Nursing, and contact concerned District Medical and Health Officer, in respect of Private Schools of Nursing. Further, all the DM&HO's are requested to upload the selection list of GNM students in the DME website i.e within one week as per the instructions of Indian Nursing Council, New Delhi.

Further, the Superintendents of the Andhra and Rayalaseema Regions who are the chairpersons for admissions are instructed to complete the selection process for vacant seats of Government Schools of Nursing in time.

Hence the Chief Information Office, O/o Director of Medical Education, A.P, Vijayawada is requested to place the said dates in the official website of the Director of Medical Education, A.P, Vijayawada and also requested to take steps for online admission applications immediately.
