In the reference 1<sup>st</sup> cited this office have issued GNM Regular Examination notification November 2021 and extended the dates vide reference 2<sup>nd</sup> cited.

The GNM November 2021 examinations are commenced from 01-12-2021 to 24-12-2021 **with instructions that Separate Examination notification will be issued for GNM 1<sup>st</sup> year Students admitted in the year 2020-21 as the Indian Nursing Council, New Delhi issued orders to treat the 20-21 batch as special batch in view of Covid-19 vide F.No : 1-6/(LT)-2021-INC Dt : 08-03-2021.**

In view of the oncoming COVID Situation in the country and OMICRON surge certain instructions are issued to the Superintendents of the teaching Hospitals/ Principals of Government and Private Institutions in the state regarding the submission of Examination applications well in advance to avoid further consequences in conduction of 1<sup>st</sup> year Regular exams of 2020-21 batch as detailed below.

1. The Examination dates for 1<sup>st</sup> year GNM students of 2020-21 batch will be intimated later.
2. Internal assessment marks should be uploaded through online only. Otherwise the applications will not be accepted.
3. Last Date of payment of Examination fee : 18-01-2022
4. Last date of submission of the applications at the scrutinizing centers : 21-01-2022.
5. The Superintendents of the Teaching Hospital/Principal of the Government schools of Nursing of the concerned Scrutinizing centres are directed to accept the examination applications as per the dates mentioned above strictly and scrutiny has to be done as per the instructions given in the notification vide reference 1<sup>st</sup> cited and as per the INC rules & Regulations and submit the scrutinized applications of their securitizing centre in Nursing Education Section O/o the Director of Medical Education, A.P, Vijayawada on or before 24-01-2022 by 12.00 Noon.

Further, All the Principals of both Government and Private Schools of Nursing are hereby directed to strictly follow the above instructions and inform to all the concerned exam going students well in advance duly displaying the same prominently in all the notice boards and other means of communication.
