In the reference 2nd and 4th cited, General Secretary, Andhra Pradesh Nursing Institutions Management Association have represented to the DME for extension of dates for GNM Admissions. Keeping in view of the request made by the Andhra Pradesh Nursing Institutions Management Association, AP., previously, the admission schedule has been extended vide reference 3rd and 5th and 7th cited.

In the reference 8th cited, the General Secretary, Andhra Pradesh Nursing Institutions Management Association has given another representation to the DME requesting for Extension of admission dates for GNM. In the representation he has mentioned that BSc (Nursing) counselling has not completed and the candidates who did not get the seats in BSc (N) course will join the GNM Course and also mentioned that Indian Nursing Council, New Delhi has extended the admission date till 30-11-2023 and requested for extension of dates

In this context, vide reference 9th cited, Indian Nursing Council, New Delhi has extended the last dates for admission to nursing programmes i.e ANM, GNM, BSc (N), PBBSC (N), MSc (N), Post Basic Diploma and NPCC for the academic year 2023-24 till to 30th November 2023 and mentioned that NO request for further extension shall be considered.

In view of the above, the admission schedule is revised as follows:

- 1. Payment of Registration fee is extended up to 30.11.2023.
- 2. Online submission of applications and submission of downloaded applications are extended up to 30.11.2023 till 5.00 P.M. for Govt. Schools of Nursing.
- 3. Online submission of applications and submission of downloaded applications are extended up to 30.11.2023 till 5.00 P.M. for private schools Convener Quota.
- 4. Online submission of applications and submission of downloaded applications are extended up to 30.11.2023 to 5.00 P.M. for private schools Management Quota.
- 5. Selection process should be completed by 30.11.2023 for Govt. Schools and Private Schools by DM&HOs.
- 6. Commencement of classes will be from 01.12.2023.
