- 4) All Applications of the candidates appearing for examinations should be submitted in Color Printed form. Black and white application copies will not be accepted.
- 5) As per the examination schedule, the candidates should produce their practical Record at the examination center concerned.

- 6) The Principals of Government Colleges of Nursing are informed that necessary instructions may be given to their students concerned that while filling up the Application form **Online**, the name of the student/Father or Guardian Name/ Institution as per their S.S.C. Certificate including identification marks IN BLOCK LETTERS ONLY, AND NO CORRECTIONS WILL BE ENTERTAINED LATER ON.
- 7) The Principals of the Colleges of Nursing are instructed to submit the Attendance Certificate for both theory and Practicals of the students of their concerned along with hard copy of the examination applications to the concerned centers. They are also informed that unless the internal Assessment marks are uploaded, the applications will not be accepted through online. Examination: The Theory and practical examination have to be conducted by the Nursing Education board by the Director of Medical Education.

• ELIGIBILITY FOR ADMISSION TO EXAMINATION:

- Percentage of attendance in theory and practical examination should be 90%.
- Candidate who successfully completes the necessary requirements such as logbook and clinical requirements is eligible and can appear for final exam.
- However, students should make up 100% of attendance for integrated practice experience and internship in-term of hours and activities before awarding the certificate.

• STANDARDS OF PASSING

- 1. In order to pass a candidates should obtain at least 50% marks separately in internal assessment and external examination in each of the theory practical and papers.
- 2. Less than 60% is second division.
- 3. 60% and above and below 75% is First division.
- 4. 75% and above is distinction.

- Medical faculty/preceptor from Obstetrics and Gynaecology, Pediatrics and Public Health with 3 years post PG experience/Consultant.

CERTIFICATION

- Title–Nurse Practitioner in Midwifery (NPM) Post Basic diploma programme
- The title is awarded upon successful completion of the prescribed study program:
 - $\circ\,$ Has completed the prescribed course of Nurse Practitioner in Midwifery program for a period of 18 months
 - Has completed 90% of the theoretical and 100% of the practical instruction hours before awarding the certificate.
