In the reference 1<sup>st</sup> cited, this office have issued admission notification for General Nursing and Midwifery Course (3 years) for the Academic year 2024-2025 batch which is being imparted in Government and Private Schools of Nursing in the state.

In the reference 2<sup>nd</sup> cited, previously, the General Secretary, Andhra Pradesh Nursing Institutions Management Association have given a representation to the DME for extension of dates and vide reference 3<sup>rd</sup> cited, Indian Nursing Council, New Delhi extended the last date of admission to nursing programs i.e ANM, GNM, B.Sc (N), PBB.Sc (N), M,Sc (N), Post Basic Diploma and NPCC from 30<sup>th</sup> September to 31<sup>st</sup> October 2024.

In view of the request made by the Andhra Pradesh Nursing Institutions Management Association, AP, this office has extended the last dates for Payment of Registration fee, online submission of applications and submission of downloaded applications till 25-10-2024 giving time for completion of selection process by 31-10-2024 vide reference 4th cited.

Further, in the reference 5<sup>th</sup> President, Andhra Pradesh Nursing Institutions Management Association have given another representation to the DME for extension of dates till 30<sup>th</sup> November 2024.

In the reference 6<sup>th</sup> cited, Indian Nursing Council New Delhi has once again extended the dates for all Nursing programmes i.e, ANM, GNM, B.Sc(N), PBBSc (N), MSc (N), Post Basic Diploma and NPCC for the academic year 2024-25 till 30<sup>th</sup> November 2024. Further informed that"

- a. The total number of students admitted up to 31-10-2024 (Regular batch) and 30-11-2024 (Irregular batch) should add up to the sanctioned strength and shall not exceed the Annual intake.
- b. A Candidate must have minimum of 80% attendance (Irrespective of kind of absence) in theory and practical in each subject for appearing for examination. The diploma shall not be awarded to the student till she/he has completed the clinical/filed requirement.

In view of the request made by the Andhra Pradesh Nursing Institutions Management Association, AP., the admission schedule is revised as follows:

- 1. Payment of Registration fee is extended up to 20-11-2024.
- 2. Online submission of applications and submission of downloaded applications are extended up to 20-11 -2024 till 5.00 P.M. for Govt. Schools of Nursing.
- 3. Online submission of applications and submission of downloaded applications are extended up to 20-11 -2024 till 5.00 P.M. for private schools Convener Quota.
- 4. Online submission of applications and submission of downloaded applications are extended up to 20-11 -2024 to 5.00 P.M. for private schools Management Quota.
- 5. Selection process should be completed by 30-11-2024 for Govt. Schools and Private Schools by DM&HOs.
- 6. Commencement of classes will be from 02 -12 -2024. (for irregular batch)

Further, All the Principals of the Government/Private GNM Schools are hereby instructed to follow the guidelines issued by the Indian Nursing Council, New Delhi Scrupulously.
