In the reference 1st cited, this office have issued admission notification for General Nursing and Midwifery Course (3 years) for the Academic year 2024-2025 batch which is being imparted in Government and Private Schools of Nursing in the state.

In the reference 2<sup>nd</sup> cited, the General Secretary, Andhra Pradesh Nursing Institutions Management Association have given a representation to the DME for extension of dates stating that due to recent floods in many districts of Andhra Pradesh, many houses were damaged and the certificates of many candidates were lost and could not be retrieved. Such candidates has to get their duplicate certificates of SSC, Intermediate marks memos and also stated that the BSc (N) counseling is not yet started and the candidates who did not get the seats in BSc (N) course will join in GNM course and requested to extend till 31-10-2024 for payment of Registration fee and online submission of applications.

In this context, vide reference 3<sup>rd</sup> cited, Indian Nursing Council, New Delhi has informed that in continuation to earlier notification no.3 of 2024 & 4, extended the last date of admission to nursing programs i.e ANM, GNM, B.Sc (N), PBB.Sc (N), M,Sc (N), Post Basic Diploma and NPCC from 30th September to 31st October 2024 and mentioned that NO further extension will be granted.

In view of the request made by the Andhra Pradesh Nursing Institutions Management Association, AP., the admission schedule is revised as follows:

- 1. Payment of Registration fee is extended up to 25-10-2024.
- 2. Online submission of applications and submission of downloaded applications are extended up to 25-10-2024 till 5.00 P.M. for Govt. Schools of Nursing.
- 3. Online submission of applications and submission of downloaded applications are extended up to 25-10-2024 till 5.00 P.M. for private schools Convener Quota.
- 4. Online submission of applications and submission of downloaded applications are extended up to 25-10-2024 to 5.00 P.M. for private schools Management Quota.
- 5. Selection process should be completed by 30-10-2024 for Govt. Schools and Private Schools by DM&HOs.
- Commencement of classes will be from 02-11-2024.
