It has been proposed to prepare seniority list from feeder categories for the post of **Dietician** in the institutions under the control of the Director of Medical Education, Andhra Pradesh by the eligible in-service candidates by way of appointment by transfer from any other category governed by rules in terms of Government orders mentioned in the reference cited for the panel year 2025-26.

Dietician: As per G.O.Ms.No.154, HM&FW(A2) Dept., Dated:04.05.2002 and amendment in G.O.Ms.No.232, HM&FW(M1)Dept., Dated:15.10.2009 the method of appointment to the cadre of Dietician is as follows and G.O.Ms.No.70, HM & FW (A1) Dept, dt:14.05.2024.

Method of Appointment :

- i. "By appointment by transfer of qualified Head Nurses from the Andhra Pradesh Nursing Sub-ordinate Services and qualified candidates from any of the categories in Andhra Pradesh Medical Sub-ordinate Services and Andhra Pradesh Public Health Sub-ordinate Services".
- ii. If no qualified person is available for appointment by method (i) above, by direct recruitment.

Qualification:

- iii. Must possess a B.Sc., degree from a recognized university and post Graduation/Post Graduation Diploma in Deictics or Nutrition or Food Sciences from recognized university".
