It is brought to the notice to the Government that the disturbing trend of unauthorized absence from duty continues unabated, thus all Head of the Department under administrative Control of HM&FW, A.P., have been requested to immediately obtain comprehensive details of all such cases of unauthorized absence occurring since June, 2024. The detailed report must be furnished to the Government quickly to facilitate the taking of further necessary disciplinary and administrative action in the matter.

It is informed that a Show cause notice has already been issued to certain (12) Associate Professors, (48) Assistant Professors and (2) Tutors who have been unauthorized absence for their duties more than one year, as to why action should not be taken to remove them from Government service under FR 18-A and Rule 5-B of A.P. Leave Rules, 1933 and in accordance with the Government Orders and requested to submit show cause within (15) days from the date of receipt of the show

cause notice.

To the above Show Cause notice, (3) Associate professors and (3) Assistant professors have submitted representations and requested for posting orders.

The remaining following individuals have failed to submit the explanation to the show cause notice and also failed to report for duty and continue to remain absent without authorization for more than one year. Their conduct constitutes a violation of Rule 18-A read with Rule 5-B of the A.P. Leave Rules, 1933. As per the Government Orders cited in the references, unauthorized absence for more than one year is liable to be treated as "deemed resignation" from Government service.






